Dear Parents and Carers

The Gold Creek School Board has reviewed the level of family contributions and have simplified the contribution structure.

For 2018:

First student (Preschool to year 10) — \$110

For each additional student — \$90

New families to GCS are requested to pay an additional \$140 resource contribution.

Subject Electives - \$20 per student for year 9 – 10 per semester

\$10 per student for year 7 – 8 per term

Family contributions are used to fund the school in many ways which help to support the funding that the education directorate allocate. Some examples are sporting equipment, library books, resources, computer technology. Contributions are also used to fund curriculum materials in science, technology, languages, as well as International Baccalaureate PYP and MYP program.

You can pay your family contribution in one of three ways;

1. Voluntary contribution; or
2. Donation to the fully tax-deductible Library Fund; or (non-refundable)
3. Donation to the fully tax-deductible Building Fund. (non-refundable)

Payment methods

Payments can be made by credit card, EFTPOS, cheque and direct deposit into the School's Westpac bank account, Gold Creek School Management Account, BSB:032 777, Acc: 001340.
